**Monthly Pass Program Terms:**

Upon approval and acceptance of this Application for Mr./Mrs. \_\_\_\_\_ their Monthly Pass at Apple Valley Country Club is valid for \_\_\_\_\_ continuous month(s) upon the payment of \$ \_\_\_\_\_. The Monthly Pass is a calendar month-to-month program (ends the last day of an applicable month), however Monthly Passes may be paid in advance as long as the months are continuous (no break between months). Payment is due by the 1<sup>st</sup> of the month, or prior to the first time the Monthly Pass Holder(s) plays in a month. Monthly Pass fees will not be prorated. The terms and prices of the Monthly Pass Program are subject to change without notice unless prepaid.

- Purchase of a Monthly Pass entitles the eligible golfer(s) to golf at no additional charge during normal business hours for the month(s) purchased.
  - NOTE: Purchasing a Monthly Pass does not entitle the Monthly Pass Holder to free golf during tournaments or other special events.
- Tee times can be made no more than ten (10) days in advance.
- All play must start from the 1<sup>st</sup> tee, unless otherwise designated by the Golf Shop.
- Players MUST check in with the Golf Shop Staff and receive a receipt prior to each round of golf.

I have read the Monthly Pass Program Terms above and the Rules and Regulations at Apple Valley Country Club (“the Club”) below and fully understand the terms and conditions contained herein and agree to abide by them. Acceptance of a Monthly Pass at the Club constitutes acceptance and agreement by the Monthly Pass Holder(s) and if applicable, such Monthly Pass Holder’s spouse/significant other, children and guests to abide by the Rules and Regulations as they may be amended from time to time.

**Rules and Regulations at Apple Valley Country Club (“the Club”)**

Monthly Pass Program: If a Family Monthly Pass is purchased, the spouse/significant other of a Monthly Pass Holder and the Monthly Pass Holder’s children living in the same household under 21 years of age shall have full rights and privileges extended by the Monthly Pass Program, subject to the terms and provisions of the Monthly Pass Program. Monthly Pass fees are non-refundable.

Payment of Fees & Obligations: Monthly Pass Program fees are to be paid in advance. The Town of Apple Valley shall have the right, in its sole discretion, to change the fees and/or Monthly Pass Program Terms. Failure to pay any amount due pursuant to the terms as referred to heretofore, is cause for immediate suspension and/or termination of Monthly Pass Program. In the event of expulsion, notice by the Club in any form of means directed to Monthly Pass Holder’s last known address, shall be sufficient.

Reinstatement of Monthly Pass Program: All existing obligations, interest, and penalties must be paid in full before reinstatement will be considered. It is the Town of Apple Valley’s sole decision whether or not reinstatement will be granted or not.

Monthly Pass Holders Conduct: Conduct of an offensive nature or deliberate damage to Club property or person will be cause for expulsion from the Club, including having the Monthly Pass Revoked with no refund. Monthly Pass Holder(s) will be responsible for any and all damage caused by themselves, their spouse, and their children; the Monthly Pass Holder will immediately reimburse the Club for any damage and/or necessary repair to property. The Town of Apple Valley has the right to cancel any Monthly Pass, at any time, at its sole discretion.

Dress Code: Monthly Pass Holder(s) are expected to adhere to the Club's Dress Code Policy while on the golf course and practice facility.

No Show Policy: The Club asks when a golfer will not be using a tee time previously reserved; the tee time must be cancelled by calling the Golf Shop as soon as possible. If excessive amounts of No Shows occur, the offending Monthly Pass Holder will not be allowed to make tee times in advance and will be allowed to play only as a Walk-on golfer.

Change of Address: Monthly Pass Holder(s) must notify the General Manager/Director of Golf of any Change of Address. The failure of a Monthly Pass Holder to receive notices and/or bills as a result of such unnotified change of address will not relieve the Monthly Pass Holder from the Rules and Regulations as set forth herein.

Monthly Pass Holders Liability: A Monthly Pass is only a rental of Club privileges and does not confer any ownership in the Club, Club property or its assets, nor is the Monthly Pass Holder liable for any assessments or liabilities accruing against the Club, its properties, or assets other than damage to the Club as a result of Monthly Pass Holder actions. In consideration of the privileges herein described, each Monthly Pass Holder and each person using the facilities, equipment and amenities of the Club through a Monthly Pass, expressly agrees that (i) all use of the Club's facilities, equipment and amenities is undertaken at the sole risk of the user, and the Club shall not be liable for any injuries or damages to any Monthly Pass Holder or other persons; and (ii) the Club and its owner, affiliates, officers, directors, shareholders, agents and employees shall not be subject to and are hereby released and forever discharged from any claims or demands whatsoever, including, without limitation, those claims or demands resulting from acts or omissions of active or passive negligence on the part of the Club or its owner, affiliates, officers, directors, shareholders, agents or employees.

Facilities: The obligation to pay fees is not dependent on the availability of all the Facilities or the frequency of use. Repair and maintenance of Facilities and/or other occurrences may make it necessary for the Club to change hours of use or restrict the use of the Facilities or to close the Club temporarily. The Club will not reduce or suspend fees during the time when the Facilities, in whole or in part, are not available. The Town of Apple Valley reserves the right, in its sole and absolute discretion, to discontinue or modify operation of any or all of the Facilities; to sell or otherwise dispose of the Facilities; and to make any other changes in the terms and conditions of Monthly Pass Program or the Facilities as determined by The Club. The Town of Apple Valley may extend privileges of the Club and the right to use the Facilities to such other persons and upon such terms as the Club may from time to time prescribe. The Club will have the ability to book group outings/tournaments as far in advance as the Club sees fit. If Monthly Pass Holders would like to play in a group outing/tournament, the Monthly Pass Holder will be responsible for paying the full entry fee of that event.

Personal Golf Carts: Monthly Pass Holder(s) with personal golf carts must have adequate insurance and the Club's Personal Golf Cart Entry Permit must be completed and signed. The use and availability of a personal golf cart is granted to those Apple Valley Country Club Members who were Members on December 10, 2008 and who have paid applicable Trail Fees since April 1, 2010. Personal Golf Cart use at the Club is subject to change without prior notice. Other individuals that are not Apple Valley Country Club Members may not use their personal golf cart on the golf course at any time.
